First aid:

Change contaminated clothing. After skin contact: Wash skin with soap and plenty of water immediately. After eye contact: Wash eyes thoroughly with water. Consult an ophthalmologist. After swallowing: Call a doctor immediately. Symptomatic treatment is recommended.

Mode of action:

The active ingredient, imidacloprid, acts by binding to the insects neurons. This binding causes a disturbance in the transmission of nerve impulses which is lethal to the target insect. The product contains the pheromone cis-tricos-9-ene, attractive to flies. The product is easy to apply and provoke fast knockdown. The product contains denatonium benzoate, a bittering agent which helps to prevent ingestion by children, non-target animals and pets.

PEST	DOSAGE	REMARKS
House Fly and Stable fly Spray application	Pour 10 g of Fly Spray 10% in 200 ml of water	Mix well and let mixture stand for at least 15 minutes. Using a pressure sprayer apply the mixture withing 7-8 hours after mixing. Apply on non-porous surfaces such as walls and pipes where flies usually lay or hang strips of cardboard treated with the mixture.
Paint application	Pour 10 g in 150 ml of water.	Mix well and let it stand for at least 20 minutes before application. Apply the mixture with a paint brush directly to non porous surfaces like high walls, pipes and window ledges where flies usually lay or hang strips of cardboard treated with the mixture.

The product shall be applied to an effective surface of 1 m² per 100 m² floor surface to be treated.

Tip: Add moisture (water) when the product has dried to enhance its activity.

Intended uses: For indoor use on livestock premises such as broiler and breeding houses, livestock barns, dairy parlours, caged layer houses and small animal husbandry such as kennels, etc., commercial / industrial and public areas such as hospital wards, hotels, public baths, municipal buildings, churches, halls, community centres, cinemas, etc. and Domestic environments such as rooms where household wastings is stored.

Remarks: Apply only in empty premises or in places where direct or indirect contact with people/animals is not likely. Do not apply in areas where regular cleaning can move the bait to the surfaces that come into contact with foodstuffs. Do not apply in areas regularly cleaned with water as the washing can remove the deposit. Do not apply in areas recently sprayed with insecticide. Do not spray insecticide on the granules. The application on textile may cause discoloration.
